

CERTIFICATE OF B.C. OWNERSHIP

Information and Definitions

This declaration is required to be completed by every for-profit organization applying for a grant from the Amateur Sport League Fund (the “Fund”) administered by viaSport with support from the Province of British Columbia. Failure to complete this declaration will result in denial of application.

Eligible amateur sport leagues and teams operated by for-profit organizations can receive a grant from the Fund ONLY WHERE:

- the organization that applies for the grant is registered in B.C.;
- the organization pays taxes in B.C.; and
- the organization is B.C.-owned.

For the purposes of the Fund and this declaration “B.C.-owned” is defined as follows:

1. **In the case of a corporation**, not less than 51% of the outstanding and issued shares of the corporation, including voting and non-voting shares of every class, are owned by individual or entities which are residents of British Columbia, as demonstrated by the registered address of each shareholder as listed on the central securities register for the corporation;
2. **In the case of a partnership**, not less than 51% of the total partnership units or interests, including limited partners, are held by individual or entities which are residents of British Columbia, demonstrated by the registered address of each partner as listed on the statement of registration filed with the registrar;
3. **In the case of a sole proprietorship**, the proprietor is a resident of British Columbia, as demonstrated by the registered address listed on the statement of registration filed with the registrar.

If an organization is currently “B.C.-owned” according to the above definitions, but has plans or intentions to change its ownership such that it would no longer be “B.C.-owned”, it should not apply for a grant from the Fund.

The declaration must be made by the President, CEO (or similar position) or Board chair of the applicant-organization. This person must personally review the central securities register or statement of registration (as applicable), and complete and sign the declaration that follows.

If it is subsequently determined by viaSport that the Applicant was, in fact, not “B.C.-owned” as of the date of the declaration, the Applicant will be responsible to promptly repay the full amount of any grant it has received from the Fund.
